Terms

- In order to reserve a date, we must receive the mandatory \$100.00 Security Deposit.
- A \$250.00 Security Deposit is required when Alcoholic Beverages will be served at your event by a licensed caterer.
- Security Deposit will be returned within 14 days as long as area meets the clean-up checklist and there is no negligent damage during rental.
- Deposits will be refunded only if event is cancelled at least 21 days prior to the event.
- Total Rental fees must be paid no later than 21 days prior to the event.
- A \$25.00 surcharge will be applied to all checks returned for insufficient funds.
- Renters will be responsible for any damages incurred to the facility during their event.
- Smoking anywhere in the entire facility or on the premises is strictly prohibited except in specifically designated areas.
- All alcoholic beverages must be served by licensed caterers only. NO BYOB.
- Fire Exits shall remain free of obstruction at all times.
- Children under 8 require adult supervision on playground and ball field.
- It is acknowledged that failure to adhere to this contract may result in denial of future use of the facility.
